
USGA RULES GOVERN ALL PLAY

- All players must register in the golf shop PRIOR to starting play.
- 2. Play must begin on the tee assigned by the golf shop.
- Proper golf attire is required to play golf. Men are required to wear shirts and shoes. NO bathing suits, tank tops, cut off jeans or halter tops will be allowed.
- Practice is restricted to the driving range and putting green.
- Management may, at its discretion, join groups together for ease of play.
- Players must repair all ball marks and rake bunkers after play.
- Use cart paths where provided. If direct crossing is needed use 90° rule.
- Only 2 persons permitted in or on carts at any time.
 You must have valid drivers license to drive any cart on club property. (Private or club owned)
- No more than a fivesome allowed on holiday or weekends.
- 10. Children under 12 must be accompanied by an adult.
- Please be considerate of players behind you. ALLOW faster players through.
